It is understood that the recipient of a Food and Resource Economics Department scholarship will meet the following criteria:

- Be enrolled in a FRE major
- Be registered as a full-time student (Undergraduate: 12 hours minimum; Graduate Student: 9 hours)
- Have a minimum of 2.5 GPA (most scholarships require a 3.0 or higher GPA)

Scholarship applications are evaluated on the basis of scholarship, leadership, professional potential and in some cases, financial need. Recipients are selected during the summer semester and scholarships are awarded for the following fall and spring semesters. All applicants will be notified of a decision by April 9, 2021.

Stated scholarship amounts are approximate and historical. The amount of each award may vary depending on the applicants, the number of awards given and funding available.

Applications are due March 19, 2021. Incomplete applications will not be considered.

***Need Based Awards:** Student MUST be certified by SFA as “needy” and must have a current FAFSA on file with Student Financial Aid. FAFSA form is located at www.fafsa.ed.gov. Students not eligible to apply through FAFSA must complete a Determination of Financial

AVAILABLE TO FRE UNDERGRADUATE STUDENTS ONLY

Hal. W. Lively Memorial Scholarship (65% of the cost to attend UF, approx. \$13,8K each year. This award will be paid in ½ increments each semester, Fall and Spring.)
Support scholarship for majors in agricultural economics specializing in food marketing and distribution. To be eligible for this award recipients must be a Florida resident and completed course work for the freshman and sophomore years; must maintain field of study, be in good academic standing and make satisfactory progress toward graduation. Failure to do so will result in forfeiture of additional payments. Juniors receiving this scholarship will receive the amount for four total semesters.

***R. Holt Howard Endowed Scholarship Fund** (\$500) (THIS IS A NEED BASED AWARD)

Support scholarships for undergraduate students in FRE. Recipients will be selected on the basis of scholastic achievement, need, and professional promise.

***Don Thomas Memorial Scholarship Fund** (\$1,500) (THIS IS A NEED BASED AWARD)

Support scholarship for undergraduate students in FRE; award is Need-Based; applicants need to have taken Business Ethics or at least one (1) credit hour of an ethics course; requires students to have a minimum 2.75 GPA; and have demonstrated community service.

Support undergraduate or graduate student(s) majoring in FRE. Selection of student(s) shall be based on financial need first and academic achievement second. Preference in the selection of the student(s) to receive this scholarship shall be given to students who have graduated from a Florida high school with an agricultural background. The student(s) should have a sincere desire to pursue a career related to agriculture in the state of Florida.

J. E. Ross International Travel Award (\$1,250)

Support international travel assistance to graduate students in FRE who are preparing for careers in international trade and development. Please include a budget in your statement. This award will be disbursed at the time of travel.

Phillip L. Herndon Endowment in Economics (\$2,000)

Support graduate students studying citrus related economics in FRE either on campus or in a distance education program; students must have a minimum 3.0 GPA.

Harold B. Clark Award: (\$2,000)

Provide financial support for students in FRE to engage in research projects and professional development/employment opportunities, both in academics and the private sector. Such opportunities include travel needed to conduct research and travel to present research results at professional meetings; such support is to be awarded on merit with preferences to graduate students. It is the donor's wish that the recipients of this award will consider donating back to this fund later in their career when they are more financially secure thereby helping future students realize their professional goals.
