#### **Course Description:**

The course examines the need for emergency assistance in other countries to minimize losses and affect recovery from various circumstances. The topics includes the legal/ethical basis for humanitarian efforts; program designs promoting recovery, rather than dependence; cultural issues, including gender; and technical aspects. Students will identify, describe, and explain social institutions, structures or processes that have direct implications for international humanitarian assistance. They will also develop global and intercultural awareness about practices and efforts surrounding humanitarian assistance.

## Expected Student Learning Outcomes:<sup>1</sup>

This course is part of the Social and Behavioral Sciences and International General Education subject areas. After the successful completion of AEB 4282, a typical student should be able to:

- 1) Construct opinions through research and articulate these opinions to others concerning humanitarian issues.
- 2) Evaluate current and past humanitarian crises, their purported causes, and possible solutions.
- 3) Analyze the macro issues regarding the systems in place to provide humanitarian assistance: How do the individual "pieces" like governmental organizations, private entities and citizens, the political landscape, cultural values and norms, economic systems, etc., fit together in the larger scheme of things?
- 4) Create philosophical / ethical concepts and positions that can be convincing to others about actions, practices, and policies which you would like to see implemented.

# **Required Texts:**

There is no textbook required for this class. Instead, I will pull notes from several different sources and occasionally assign readings for class. All readings are located in the CANVAS class files for the course. Even lacking a "book" or set of books, however, THERE IS A LOT OF REQUIRED READING FOR THIS COURSE. In our modules look for items that say **READ**. These are required readings for the course.

- 1. Exams (2 @ 200pts)
  - *Exams are multiple choice and short answer that will cover the lectures as well as the readings.*
- 2. Humanitarian Interview (50pts)
  - Conduct an interview with an organization that directly or indirectly addresses a humanitarian issue. Details provided in canvas.
- 3. Crisis PowerPoint Presentation (100pts)
  - Choose a humanitarian crisis (can be an ongoing one, a historic one, one discussed in class, or one that we do not discuss). Create a PowerPoint presentation (with voiceover) of approximately 10 slides that address the overall issue, current and past attempts to remedy the situation, and what you would suggest as future steps (a detailed rubric will be provided).
- 3. UN Taskforce (200pts)
  - Early in the semester you will be assigned to a country which is part of a UN taskforce. There are three taskforce groups concerning different areas that relate to humanitarian issues. You will then be tasked with representing your country as part of that taskforce meeting. Components of this activity include an opening statement, evaluation of other representatives, and an instructor evaluation. Details will be provided through Canvas. These taskforce meetings will be held the last week of class.
- 4. Final News Article (150pts)
  - Write a one two-page summary of the proceedings of your taskforce meeting. Treat this like a news article showing highlights of the event. This assignment is individual. It is due on the date of our final exam.
- 5. Participation (20 @ 6.25pts)
  - Throughout the semester we will have twenty in-class participation activities. Your four lowest scores will be dropped.
- Extra Credit Humanitarian Organization Review
  - Conduct a review of the efforts and effectiveness of an international humanitarian organization of your choice.

# **In-Class Recording**

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled.

A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
