This course emphasizes the role of agriculture and economics. The hows and whys of their influence on food prices and the world food situation, the environment, natural resources and government policy; and economic issues, including inflation and money.

Expected Student Learning Outcomes:

The primary goal of this course is to explore economic concepts that will enable critical analysis of food-related choices from the context of individual consumers and as global citizens. At the conclusion of this course, the successful student will be able to:

- Use analytical models to generalize economic decision-making associated with food supply and demand, productivity gains from investment and technological advances, market failures associated with pollution and common resources, the situation of income inequality and unemployment, as well as the basic tools of fiscal, monetary, and agricultural policy analysis influencing society's well-being.
- Apply positive and normative economic analysis to examine how different sectors of the U.S. economy are interconnected, and to analyze current local and global economic issues surrounding food, resources, and policy design.

Required Course Materials

There is no specific textbook required for this course. Readings are based on open-source textbook materials available online and additional readings for each lesson are supplemented in Canvas.

Course Outline

• Module 1: Introduction to Economics

Students will be able to define foundational economic concepts such as scarcity, opportunity cost, markets, and trade-offs. They will understand the role of agriculture and food systems in economics and apply demand and supply theory to real-world examples.

• Module 2: Consumer Behavior

Students will understand how individuals make consumption decisions. They will be able to explain marginal utility, consumer surplus, and different types of price elasticities, and apply these concepts to analyze consumer choices in agricultural and food markets.

• Module 3: Production, Firm, and Market Structure

Students will examine how firms make production decisions in both the short run and long run. They will analyze cost structures, market competition, and different market structures, including perfect competition, monopoly, monopolistic competition, and oligopoly.

• Module 4: Public Goods and Externalities

Students will understand market failures and evaluate the role of government intervention. They will be able to explain externalities, public goods, and common resources, and analyze related agricultural and environmental issues using economic frameworks.

• Module 5: Macroeconomics

Students will explore key macroeconomic indicators, such as GDP, inflation, interest rates, and unemployment, and analyze how these factors influence food prices, agricultural production, and consumer purchasing power.

• Module 6: International Trade and Agricultural Policies

Students will examine international trade theories and agricultural policy tools. They will explore how trade, environmental regulations, and food policies affect markets, producers, and consumers at both national and global levels.

Course Grading Structure

Assignments:

Students will complete one assignment at the end of each module. Each assignment follows a two-deadline system. The first deadline is due in one week after the lesson (for students who need strict deadlines). The second deadline is due on the exam day (I will manually change the due dates after the first deadline). Students may choose whichever deadline best supports their time management, as effective planning is essential for success in this course. Late submissions are allowed, but a 20% deduction per late day will be applied.

It is strongly advised not to postpone assignments until just before the exam, as the material may be too extensive to absorb in a short time. Students should space out their study sessions, review mistakes carefully, and seek to understand each concept before moving on.

Practice Quiz:

Practice quizzes will be conducted in person. After each module, there will first be a review session followed by a practice quiz. The review, quiz, and assignment questions will be similar and will cover most of the content needed for the exam. The quiz functions as both a review tool and an attendance check; students will see which answers were correct or incorrect but will receive full credit as long as they attend and submit the quiz. This structure is designed to help students actively review the material and assess their understanding of the module content.

Article Application Essay:

Students will complete one short essay that connects a current news article, report, or credible source to an economic concept discussed in class. The goal is to apply economic reasoning to real-world issues in food, agriculture, markets, or policy. Students may choose any relevant article but must ensure it relates to one specific topic covered in the course (e.g., elasticity, market structure, externalities, monetary policy, international trade).

The essay should be 1-2 pages in length (approximately 500-700 words) and should include a concise summary of the article, highlighting the key issue, facts, or findings. Students then clearly connect the article to a specific economic concept covered in the course and explain how the chosen topic applies to real-world economic behavior. Finally, a brief analysis or reflection should be included to discuss why this issue is important for consumers, producers, or policymakers. Students may use news articles, government reports, industry publications, or

academic summaries; however, all sources must be cited appropriately using a standard citation style (e.g., APA format).

Exams:

There are six modules in total, and one exam after every two modules. There will be 3 required non-cumulative exams. All exams will be in person and closed-book. Exam questions will be drawn from the textbook, assignments, reviews, and practice quizzes.

BEWARE! 'Getting the right answer' is not the same as understanding the concept. You must understand the concept, not simply get the answer right. You will be asked questions on the exams on the same material, but they will not be the same questions – they will be asked differently, worded differently – and you must understand the concept to be sure of doing well on the exams.

Final Exam (Optional):

An optional comprehensive final exam will be given on April 29, from 12:30 PM to 2:30 PM. Students wishing to replace an exam grade from the semester may take the final exam. Students who miss an exam for any reason (excused or unexcused) may take the final to replace the missing grade. However, any student found cheating on an exam will receive a 0 for that exam and may not use the final exam to replace the grade.
