Online Course Description

Credits: 3. Prerequisites: none. The role of agriculture and economics: the how's and why's of their influence on food prices and the world food situation, the environment, natural resources and government policy; and economic issues, including inflation and money.

Learning Objectives

The primary goal of this course is to explore economic concepts that will enable critical analysis of food-related choices from the context of individual consumers and as global citizens.

At the conclusion of this course, the successful student will be able to:

- Use analytical models to generalize economic decision-making associated with food supply and demand, productivity gains from investment and technological advances, market failures associated with pollution and common resources, the situation of income inequality and unemployment, as well as the basic tools of fiscal, monetary, and agricultural policy analysis influencing society's well-being.
- Apply principles of positive and normative policy analysis to assess how parts of the U.S. economy are inter-related and further develop an ability to analyze current economic issues and problems related to food that are both local and global in context.

Due Dates

The due dates for all assignments and assessments are provided in Canvas > Syllabus tab (webpage can be printed) or dates can be programmed into your calendar or a mobile device. All assignments are due at 5:00 pm Eastern Standard time and follow “My Choices Grading” protocol (details below). It is strongly recommended that you plan to submit graded work at least one day earlier than the due date so that there is sufficient time to verify your successful “Submission Turned In!” in Canvas. In the case of other scheduled work requirements, extra-curricular activities, or other non-academic obligations, students should plan (in a schedule planner) to submit graded assignments even earlier.

The instructor reserves the right to adjust the deadlines, if necessary. All graded assignments are made available to students at least one week before an assignment is due, therefore, the Due Dates, Missed Assignment, and Extenuating Circumstances policies will be enforced.

Missed Assignment Policy

Each assignment “category” Discussions, Assignments, and Quizzes permit a drop of lowest score for final grade calculation (refer to Grading Rubric on next page). Therefore, the drop lowest score will serve as a missed assignment consideration UNLESS the Extenuating Circumstances exception applies to your specific circumstances.

*If you habitually procrastinate, or if this is your first online course, please make an appointment with the instructor early in the semester to discuss online course strategies and avoid problematic consequences.

My Choices Grading

All assignments due dates are provided in Canvas > Syllabus tab on the left-side navigation tab. Assignments may be submitted late; however, a **20% per day penalty deduction** (from Assignment Points Possible) will apply for each 24-hour period an assignment is submitted late, unless Extenuating Circumstances apply. Refer to Canvas > Module 0 “Getting Started” for details.

Extenuating Circumstances Policy

Exceptions to the Missed Assignment Policy reflect excused University events that fall under the 12-day rule or are of a serious nature. These exceptions are referred to as “Extenuating Circumstances” and require formal, letter-head documentation from a physician, hospital, UF faculty/academic advisor, or an email from the [UF Dean of Students](#) Office sent to the instructor’s UF email address, **within 24 hours of assignment deadline**. A health-clinic note on the day an assignment is due does not warrant extenuating circumstances and the Missed Assignment Policy (above) will apply.

Student Responsibility for Online Submissions

All students are responsible for ensuring their own assignment files are uploaded to the Learning Management System (i.e., “Canvas”). The instructor cannot be responsible for internet connections or failures therefore, you must verify that your assignment has been uploaded and saved in Canvas. Refer to Canvas > Module 0 “Getting Started” for details.

Students are strongly advised against using wireless connections to complete Exams or upload assignments.

Wireless connections have been problematic in previous semesters with students losing all points due to upload failure. It is recommended that you locate a hard-wired connection on campus or public library to submit graded assignments. TO REPEAT, wireless connections are problematic and quizzes or assignment uploads may not be saved (without any warning) and therefore locating a hard-wired connection is recommended to submit any graded assignments.

Special consideration cannot be granted so it is the student’s responsibility to verify their work and submissions. Hard-wired connections can be located at any UF computer lab or any public library. Failure to write independently is considered academic dishonesty – similar written responses will be submitted to Dean of Students Office for review.
3. Assignments are not difficult, but they are designed to motivate your thinking. Do not wait until the last minute to read assignment instructions or your grades will suffer due to inadequate reflection of topics assigned.
4. Quizzes will contain information provided in the lecture, textbook, and assigned readings.
5. Organize your Due Dates in a calendar, planner, or mobile device in an effort to remain organized.
6. YOU ARE STRONGLY ADVISED not to procrastinate submitting assignments. The “Missed Assignment” lowest score drop policy is intended to protect you from negative implications of life events that do happen during the semester (e.g., computer problems, forgetting assignments, family emergencies, job interviews, family responsibilities).
